1. MOTION to approve Ordinance #184 - which updates the Vehicle and Traffic Ordinances for Union Township.
2. Ridge Road Culvert – Authorize Paul to follow through on the Declaration of Taking for three small portions of property, to continue moving forward with the culvert installation on Ridge Road.

**NEW BUSINESS –**

1. Approve an amount for the Tire Collection Contribution, (last year’s amount was \$650.00). The Lebanon Tire collection will take place on Wednesday April 13, 2022, from 8:00 AM to 4:00 PM, drop off location will be the Lebanon Expo Center located at 80 Rocherty Road, Lebanon PA 17042. Applications will be available at the Township lobby, once received by the Lebanon County Conservation District.
2. Approve the Lane’s quote of \$8,107.00, for 43 linear feet of 21”x15” arched polymer pipe for Bohn’s Lane and 280 linear feet of pipe for future street crossings (2 sticks of ADS 15”, 6 sticks of ADS 18” and 6 sticks of ADS 24”).
3. Approve the Berks Traffic quote to line paint and add thermal arrows on Old Forge Road in front of Love’s Travel Stop, to help with the no parking zone. Berks Traffic quote is \$4,474.00.
4. Approve the water line quote to lower the hot/cold water lines, to be lowered outside of the attic area. G.F. Bowman was low bid at \$14,476.20. (CSE was \$19,709.00/ Precision did not bid due to the size of the project and having limited plumbing employees).
5. Approve a firewall quote, for the security of the Township’s computers. Executive Image Solutions quote for a firewall is \$150.00 per month.
6. Approved a change order from Mar-Allen for grouting work on the Biddle Road Bridge. The change order includes a larger area for repairs than contracted originally.
