

## **LICKDALE SEWER MEETING MINUTES**

The Union Township Board of Supervisors met in regular session on Wednesday, May 8, 2024. The meeting was held at the Municipal Building, 3111 State Route 72, Jonestown, PA.

**Public comments** – None

**Approve the Lickdale Sewer Meeting Minutes for April 10, 2024**, a motion was made by Kerry McCrary and seconded by Gary Longenecker. All Approved.

**Approve the Financial Report for April 2024**, a motion was made by Kerry McCrary and seconded by Gary Longenecker. All Approved.

**Operator's Report** – Dusty Keller reported that the plant is running well. Dusty stated that the VFD's came in for the sewer plant. Dusty also stated that Ditchcreek is televising the sewer lines and was waiting for the work to be completed on Old Forge Road. Dusty said that there is an 8" ductile iron line (near the elementary school and Interstate 81, may need to be addressed in the later months. For the month of April, it was wet, the average daily flows were 98,300 gallons and the total monthly flows were 2.95 million gallons. There was 5.98" of rainfall recorded during the month.

**Engineer's Report** – Scott Rights reported that the plant is running well. Scott Rights mentioned that we are working with an engineering firm for Home 2 Suites. Therefore, approval is needed for a PADEP Sewage Facilities Planning Module Exemption request for 10,150 gpd. The motion was made by Kerry McCrary and seconded by Gary Longenecker. All Approved. Scott Rights also mentioned that he received an application for sewer capacity for 11 Wolfe Lane. Scott also informed the engineering firm that the sewer capacity is not guaranteed until the new business pays for their capacity.

**Attorney's Report** – Paul Bametzreider reported that he sent the letters to the venders who are over their water usage.

**New Business** - there was none to report.

**Old Business** - there was none to report.

**Bills payable** – Sewer Fund in the amount of \$31,875.55 a motion was made by Kerry McCrary and seconded by Dennis Firestone. All Approved.
